Division into five volumes has resulted in a more durable set. In addition, pages now tend to lie flat. Inside margins are very narrow reducing the possibilities of rebinding.

In its second edition the Worldmark Encyclopedia of the Nations continues to fulfill its stated purpose. Although indexing is unsatisfactory, illustrative material sparse and questionable, binding deficient in one respect, and the subject matter is duplicated in other well-established titles, the text has been brought up to date. However, unless it is revised more frequently than in the past, it cannot be relied upon as a source of current information. The encyclopedia is written in clear and concise language and backed by an array of authoritative sources. Its accuracy and balance of coverage for all the nations of the world are acceptable. The second edition of Worldmark Encyclopedia of the Nations is recommended within the above limitations for junior and senior high school, public, and college libraries and for individuals who have an interest in the subject matter.

Chandler, George. How to find out; a guide to sources of information for all, arranged by the Dewey decimal classification. 1964. 185p. facsims. Macmillan, paper, \$2.95.

An English scholar's introductory guide to information sources is designed for high school and college students, company libraries, and curious general readers. The first in a proposed series, the present work begins with general suggestions on locating

material and then briefly describes important reference books in the various Dewey classes. There is a preponderance of English and European titles but American reference books are generously represented and the book, on the whole, has a useful place in U.S. libraries and library schools.
